- Lease Buy-Out Complete Sections 1, 2, 3 4, 5, 6 and 8.
- **Title Only** Complete entire application. Tax is due when applying for Title.
- IRP Tax & Title Must also complete IRP Application.

- Exempt Title Must also complete form T25. Vehicle must be over 15 years old, VIN verification is required.

## Types of Vehicle Ownership

- **Tenants by the Entirety/Spouses** (TEN ENT) Married couples (including Civil Unions), where ownership of property is treated as though the couple were a single legal person. Owners have a *right of survivorship*, if one owner dies, interest in the property will pass to the surviving owner avoiding probate.
- **Joint Tenants** (JTEN) Co-owners have a *right of survivorship*, if one owner dies, interest in the property will pass to the surviving owner avoiding probate.
- Tenants in Common (TEN COM) No right of survivorship, if one owner dies, interest in the property will be part of his or her estate.
- Business Partners (PTNERS) No right of survivorship, if one owner dies, interest in the property will be part of his or her estate.
- Transfer on Death (TOD) One owner only, DMV form VT-007 required.
